  - c) I have been a resident of British Columbia for at least 6 months immediately before today;

  - e) the only persons who are registered owners of the real property, either as joint tenants or tenants in common are individuals who are not holding the property in trust for a corporation or another trust;
  - f) I am not entitled to register as a resident elector in the jurisdiction;
  - g) I have not registered as a non-resident property elector in relation to any other parcel of real property in the jurisdiction;
  - h) I have received the written consent of the majority of individuals registered as owners of the real property to be registered as the non-resident property elector for this property (if applicable); and
  - i) I am not disqualified by the *Local Government Act* or any other enactment from voting nor otherwise disqualified by law.

- (1) You must meet the requirements in this section in order to register as a Non-Resident Property Elector for the jurisdiction in which the property is located. (*For Sections 1(d) add the name of the electoral area or municipality in which the property is located, for example – Area F, West Howe Sound*)
  - (2) Print applicant's surname and given names in full in block letters here.
  - (3) Print the address, municipality and postal code of applicant's residential address.
  - (4) Print mailing address.
  - (5) This is information required pursuant to the *Local Government Act*.
  - (6) Print the street address or legal description of the applicant's real property in relation to which the applicant is registering.
  - (7) This information is to identify persons who have had a name change since the last election and who were on the list of electors.
  - (8) Applicant must sign here.
  - (9) A person who was present when applicant signed his/her name on line (8) must sign here.
  - (10) Witness's address here (if witnessed by someone other than an election official)
  - (11) **You must attach the "Non-Resident Property Elector Consent Form" if there is more than one individual who is the registered owner of the real property. The person registering must do so with the written consent of the number of those individuals who, together with the person registering, are a majority of those individuals.**
- **Please note that in order to register as a non-resident property elector, the applicant must provide a copy of a valid State of Title Certificate, a current Title Search, a current Property Assessment Notice or a current Tax Notice for the property for which the applicant is registering as proof satisfactory that the applicant is the owner of the property.**
  - **If a person is registering at the time of voting, 2 pieces of identification (at least one with a signature) are required to prove identity.**
