The Sunshine Coast Regional District's (SCRD) Leisure Inclusion for Everyone (LIFE) Program provides recreational opportunities for residents with low income.

What benefits does the LIFE Program provide?

- An MYPASS access card with 52 visits, valid January 1 – December 31 at all SCR D Recreation Facilities.
- Free skate and helmet rentals at the arenas and free locker tokens at Sechelt Aquatic Centre and Gibsons & District Aquatic Facility.
- Program credit for registration in eligible SCR D registration programs.

** Cards are not transferable and have no cash value.
