- Includes 8 actions in three areas:
  - Commercial Food Waste
  - Residential Food Waste
  - Reduction Programs



# SCRD's Regional Organics Diversion Strategy

Action	Proposed Timeline
Implement curbside collection of food waste for all SCR D residences in EA's B, D, E, F receiving curbside collection of garbage.	2020
Implement residential food waste drop-off in Pender Harbour, mid-coast and south coast.	2020 budget
Investigate a Backyard Composter Subsidy Program	2020 budget
Implement a commercial food waste ban.	2020 Q4 or Jan 2021
Implement a residential food waste ban.	2020 Q4 or Jan 2021
Implement a Food Waste Reduction Campaign*	2021 budget
Implement at-home Compost Coaching Program*	2021 budget
Implement commercial food waste drop-off at the Pender Harbour Transfer Station.	On-hold
