Recommendation No. 4 Universal Water Meter Installations Alternative Approval Process

The Corporate and Administrative Services Committee recommended that the report titled Universal Water Meter Installations Alternative Approval Process be received;

AND THAT the deadline for receiving elector responses be July 24, 2018 at 4:30 p.m.;

AND THAT the elector response form be established as presented;

AND THAT the total number of electors of the area to which the approval process applies (Water Supply and Distribution Service Area) be determined to be 19,577 (10% threshold = 1,957);

AND THAT participating area approval is to be obtained for the entire Water Supply and Distribution Service Area;

AND FURTHER THAT this recommendation be forwarded to the May 24, 2018 Board meeting.
