AND THAT the Corporate Officer be authorized to file a Notice at the Land Title Office stating that a resolution has been made by the Sunshine Coast Regional District Board under Section 57(1) of the *Community Charter* against the land title of the following property:

#### BACKGROUND

Section 57(1) of the *Community Charter* allows a Building Official to recommend that a notice be registered against the land title where a Building Official observes a condition with respect to land, building or other structure that is considered to contravene a Regional District Bylaw, Provincial regulation or any other enactment that relates to the construction or safety of buildings or other structures.

This report lists a property where a building or other structure is considered to be unsafe or is unlikely to be usable for its expected purpose, or where something was constructed that required a permit or an inspection under a bylaw, regulation or enactment which have not been obtained or completed to the satisfaction of the Building Division.

Letters have been sent advising the registered owner that certain specific conditions exist regarding this property and requesting that a building permit be obtained and completed in an effort to achieve voluntary compliance.

The *Community Charter* requires that the Regional District Board must pass a resolution to place a Notice on Title. The Corporate Officer has sent a registered letter to the registered owner of the property listed in this report. The owners have been advised of the date and time of the Board meeting at which the decision to register a Notice on Title will be made, and that at this meeting they will be afforded the opportunity to speak to the issues being registered.

#### DISCUSSION

The SCRD Board adopted the following resolution on February 25, 2021:

055/21 THAT the report titled Placement of Notice on Title be received for information;

AND THAT consideration to file a Notice at the Land Title Office for the property located at Lot 1, Block 3, DL909, Plan 1275, Group 1, NWD, PID: 014-695-821, be deferred to the May 13, 2021 Regular Board meeting to provide additional time for the property to be brought into compliance with SCRD Building division requirements.

The property is non-compliant due to one or more of the following:

- permits applied for / or issued but no inspections scheduled
- construction has taken place without a valid permit.

#### 216 Camp Road / 1642 Ocean Beach Esplanade, Electoral Area E Lot 1, Block 3, DL909, Plan 1275, Group 1, NWD PID: 014-695-821 Folio: 746 01219.000

A complaint was received by the SCRD regarding the construction of a small auxiliary building taking place without a valid Building Permit. A site inspection confirmed construction and a Stop Work Order was posted on the property on September 23, 2020. To bring the property into compliance a Building Permit would need to be applied for and issued. The building could also be removed or reduced in size to under 10 square meters. To date, the building exists on the property without a Building Permit. The SCRD Building Division is not aware of any safety issues at this time and recommends notice be placed on title.

#### CONCLUSION

Section 57(1) of the *Community Charter* allows for a notice to be registered against the land title where a Building Official considers a condition with respect to land, building or other structure contravenes a Regional District Bylaw, Provincial regulation or any other enactment. Information on record with the Building Division that is summarized above show that this property is in contravention. Staff recommend that Notice is registered on Title at the Land Title Office against the above noted property.

#### **RECOMMENDATION(S)**

- 1. THAT the report titled Phase Three Water Meter Installations Project Alternative Approval Process be received for information;
- 2. AND THAT the deadline for receiving elector responses be July 7, 2021 at 4:30 p.m.;
- 3. AND THAT the elector response form be established as presented;
- AND THAT the total number of electors of the area to which the approval process applies (Water Supply and Distribution Service Area) be determined to be 21,208 (10% threshold = 2,120);
- 5. AND FURTHER THAT participating area approval is to be obtained for the entire Water Supply and Distribution Service Area.

#### BACKGROUND

The following resolution adopted at the October 8, 2020 Board meeting (in part) directs staff to proceed with an AAP to authorize long term borrowing of up to \$7,250,000 to complete Phase Three of the Water Meter Installations Project:

320/20 <u>Recommendation No. 1</u> Electoral Approval Process for Long-Term Borrowing to Fund Water Meter Installation - Phase 3

THAT the report titled Electoral Approval Process for Long-Term Borrowing to Fund Water Meter Installation - Phase 3 be received;

AND THAT an electoral approval process by Alternative Approval Process (AAP) with option to move to Assent Vote to authorize long-term borrowing to fund Phase 3 of the water meter installation project be confirmed...

#### DISCUSSION

The purpose of this report is to approve the recommendations relating to the AAP to set the deadline for receiving elector response forms, approve the elector response form and determine the total number of electors to which the AAP applies (Electoral Areas A, B, D, E, F and the District of Sechelt). Staff also recommend that the Board adopt a resolution stating that participating area approval is to be obtained for/across the entire Water Supply and Distribution

Service Area (vs by individual electoral area or municipality). This resolution must be adopted by at least 2/3 of the votes cast.

Loan Authorization Bylaw No. 730 was given three readings on March 11, 2021. A schedule for an AAP (Attachment A) has been prepared for review and adoption of the deadline for receiving elector response forms, and an elector response form (Attachment B) has been drafted for review and Board approval.

Staff have calculated the total number of electors of the area to which the approval process applies (the Sunshine Coast Regional District Water Supply and Distribution Service Area) at **21,208**. The number of electors was calculated by using the number of resident electors on the Provincial voters list in the Service Area, as received from Elections BC on January 28, 2021 (20,880), and adding the number of non-resident property electors currently registered for properties within the Service Area, excluding those property owners who also reside within the Service Area (328). This figure must be adopted by the Board (4<sup>th</sup> Recommendation). Approval of the electors by alternative approval process is obtained if the number of elector responses received by the established deadline is less than 10% of this total (**2,120**).

#### Financial Implications

The cost of statutory advertising for the AAP and additional public information advertising and outreach will be funded from the Electoral Approval Process Meters Installation Phase 3 project budget as approved during the 2021 Budget process earlier this year .

#### Communications Strategy

A communications plan has been developed for the AAP. In addition to statutory advertising, an information package will be prepared prior to the start of the AAP. The information package will include a copy of Loan Authorization Bylaw No. 730 and the AAP formal notice, as well as information on the project including cost implications for long term borrowing. Information packages will be made available at the following locations:

- > Online on the SCRD website
- SCRD office (1975 Field Road)

In order to support public participation in this AAP and recognizing the current provincial state of emergency and global pandemic, additional health and safety considerations are being implemented. Specifically:

- Providing a longer timeline for public response. The required statutory timeline to receive elector responses has been extended an additional 9 days, from 30 days to 39 days.
- Ensuring AAP response forms and information packages are available both electronically and also for pick-up at the Field Road Office during regular office hours. Completed forms may be submitted by mail or drop-off at Field Road.
- Enhanced communication efforts beyond the required statutory advertising to ensure public access to information and staff resources. This includes a dedicated project webpage, social media posts, print advertising, virtual information session(s), and ensuring direct access to staff by telephone or email for project-related AAP inquiries.

#### STRATEGIC PLAN AND RELATED POLICIES

This project supports strategy 2.1 of the 2019-2023 Strategic Plan **Strategic Focus Area for Asset Stewardship** to plan for and ensure year-round water availability now and in the future, and specifically the tactic to "complete development and implementation and plan for community engagement of a water metering program".

Enhanced communication beyond statutory requirements with respect to the AAP supports the Board's **Strategic Focus Area for Engagement and Communications**.

#### CONCLUSION

Local governments wishing to pursue long term debt financing must do so with approval of the electors. Staff have been directed to proceed with an AAP to authorize long term borrowing of up to \$7,250,000 to complete Phase Three of the Water Meter Installations Project which is the final phase of meter installations and involves installing water meters on SCRD water connections in the Sechelt area.

As part of the process, the Board must set the deadline for receiving elector response forms, approve the elector response form and determine the total number of electors to which the AAP applies (Electoral Areas A, B, D, E, F and the District of Sechelt).

If less than 10% of electors within the service area (2,120) sign and submit a completed elector response form by the deadline, elector approval is deemed to have been obtained and the Board may proceed to adopt Loan Authorization Bylaw No. 730.

Staff recommend the Board approve the recommendations relating to the AAP.
