The Sunshine Coast Regional District's (SCRD) Leisure Inclusion for Everyone (LIFE) Program provides recreational opportunities for residents living on a low income.

What benefits does the LIFE Program provide?

- MYPASS access card with 52 visits, valid January 1 December 31 for the year indicated at all SCRD Recreation Facilities for all MYPASS drop-in activities and classes. <u>www.scrd.ca/myrecreation</u>.
- Free skate and helmet rentals at the arenas and free locker tokens where applicable.
- Subsidy to offset registration fees for eligible SCRD registration programs taking place in 2023.

** Cards are not transferable and have no cash value.

2. Provide proof of income.		 Canada Revenue Agency (CRA) Notice of Assessment for each adult (19 years and older) in the household. Use your 2021 Notice of Assessment if you are applying between December 1, 2022 and May 31, 2023. Use your 2022 Notice of Assessment if you are applying between June 1, 2023 and Dec 1, 2023. 		
3. Provide proof of identity and residency.		Photocopy of Government Photo ID. If address is different from CRA Notice of Assessment, please provide: Home utility bill (eg. Hydro, gas, cable, internet, cell phone) dated within three months, OR current lease agreement.
