## SUNSHINE COAST REGIONAL DISTRICT BYLAW NO. 599

A Bylaw to impose fees and other charges for use of the Gibsons Aquatic Centre, the Gibsons and Area Community Centre, the Sechelt Aquatic Centre, and the Sunshine Coast Arena. (Consolidated for convenience only to include 599.9)

WHEREAS the Sunshine Coast Regional District has established a service for the purpose of providing for the construction, capital improvements, operation and maintenance of a new Aquatic Centre in the District of Sechelt, a new ice-based Community Centre in the Town of Gibsons, the Sechelt (Sunshine Coast) Arena and the Gibsons Aquatic Centre in the Service Area as established by *Community Recreation Facilities Service Establishing Bylaw No. 1058, 2005*;

AND WHEREAS under Section 797.2 of the *Local Government Act* and in accordance with Bylaw No. 1058, the Board may recover the annual cost of providing the service, excluding those costs for debt servicing of SCRD debt by the imposition of fees and charges imposed under section 363 of the *Local Government Act*;

NOW THEREFORE the Board of the Sunshine Coast Regional District in open meeting assembled enacts as follows:

- 1. This bylaw may be cited for all purposes as *Community Recreation Facilities Fees and Charges Bylaw No.599, 2007.*
- 2. In this bylaw the following definitions apply:

"Recreation Facility"

means any of the four major recreation facilities on the Sunshine Coast located at the following locations:

- Gibson's and District Aquatic Facility 953 Gibson's Way Gibson's BC
- Gibson's and Area Community Centre 700 Park Avenue Gibson's BC
- Sechelt Aquatic Center 5480 Shornecliffe Avenue Sechelt BC
- Sunshine Coast Arena 5982 Shoal Way Sechelt BC

"Non-Profit Organization"

means any individual, group or party, incorporated or unincorporated, whose participants are:

- are equal to or under the age of 18 years;
- an incorporated non-profit under the Societies Act of the Province of BC and/or the Canada Business Corporations Act;
- members in good standing with an affiliated or governing body;
- or,
- individuals that are gathered together on a social basis for the purposes of recreational activities; and

	"Preschool"	means an individual who is under the age of 6 years.

	"Youth"	means an individual who is equal to or over the age of 13 years and under the age of 18 years.

	"Family"	means more than one and no more than 6 individuals, at least one and maximum two of whom is an Adult, who attend a recreational facility together.

	"Prime Time"	means the time between the hours of 3:00 PM to 12:00 AM (midnight), Local Time, on School Days as defined by School District #46;

	"Non-Prime Time"	means the time between the hours of 6:00 AM and 3:00 PM on School Days as defined by School District #46;

between the hours of 6:00 AM and 8:00 AM on non-School Days.

means an individual enrolled in an education program and in possession of valid identification from the educational institution.

3. Schedules A, B, C & D, attached hereto and forming part of this bylaw, are hereby adopted as the Fees and Charges for the Community Recreation Facilities.

- 4. Fees and charges offered by and in connection with the Community Recreation Facilities shall be paid in accordance with Schedule A, B, C & D.
- 5. The fees and charges set out in Schedule A, B, C & D are hereby imposed on persons using the Community Recreation Facilities or participating in recreation or other programs offered by or in connection with the community Recreation Facilities and shall be paid in accordance with Schedule A.

6. Specific discounts and promotional pricing may be offered in an effort to promote participation in programs and services and encourage healthy lifestyles, in which case the fees set out herein shall be discounted accordingly for such purposes.
