I am writing to you on behalf of the [District of Sechelt/Sunshine Coast Regional District] to provide a letter of support for the Sunshine Coast Lions Housing Society (SCLHS) for their proposal to build a 94-unit seniors independent living apartment building in Sechelt for low- and moderate-income seniors. This project represents a positive step towards addressing the significant housing need among the senior's population living in Sechelt, as tenants will be selected from the Society's 200+ person waitlist.

The [District of Sechelt/Sunshine Coast Regional District] strongly supports the development of new multi-family housing units for seniors and people with disabilities. The [District/Regional District] recognizes the need to provide a more diverse inventory of affordable and adaptable housing units to meet a variety of needs.

Our current Strategic Plan identifies several actions to support and encourage the development of housing to address housing gaps that were identified in the 2020 Sunshine Coast Housing Needs Report. As vacancy rates drop and rents continue to increase, finding affordable housing in Sechelt is becoming increasingly difficult for seniors. This project will have a significant and immediate impact on our aging community, as directly called for in the Housing Needs Report.
