SUBJECT: PROPOSED EDWARDS LAKE SIPHON INSTALLATION

RECOMMENDATION(S)

THAT the report titled Proposed Edwards Lake Siphon Installation be received for information;

AND THAT the SCRD Board seek approval from the shishalh Nation to proceed with the installation of the Edwards Lake Siphon System;

AND THAT the installation and decommissioning of a siphon system at Edwards Lake be approved in the amount of up to \$350,000 and funded through Regional Water Operating Reserves;

AND THAT the SCRD Board request Emergency Water Provision from the Town of Gibsons;

AND THAT the SCRD Board and delegated authorities be authorized to enter into an agreement on the 2021 Emergency Water Supply with the Town of Gibsons;

AND FURTHER THAT the 2022-2026 Financial Plan Bylaw be amended accordingly.

BACKGROUND

On August 31, 2022, the Sunshine Coast Regional District (SCRD) enacted Stage 4 water conservation regulations. Due to severe drought conditions and lack of precipitation in the upper watershed, water levels in Chapman Lake and Edwards Lake have been steadily dropping.

As there is no significant precipitation in the forecast, staff are recommending that a siphon system at Edwards Lake be installed as soon as possible. The purpose of this report is to seek Board approval of the siphon installation and associated funding.

DISCUSSION

Proposed Edwards Lake Siphon Installation

In 2021, the SCRD activated an Emergency Operations Centre (EOC) to coordinate the unprecedented drought response which lasted 41 days in late summer. The region is facing similar conditions this year, and without significant rain in the forecast, staff need to seek additional sources to ensure there is sufficient residential drinking water, and water for fire protection and the Sechelt Hospital. The required rainfall to recharge the lakes to adequate levels is about 100 mm over several days.

The emergency siphon system on Chapman Lake is already in use. The SCRD needs to set up an additional water supply source to supplement the rapidly decreasing water levels at Chapman Lake should the current drought continue into October. The SCRD has developed an emergency supply plan to deploy a siphon system into Edwards Lake to augment supply, similar to the Chapman Lake emergency siphons, with proposed installation the first week of October 2022. Staff are in the process of applying for the required provincial permits, specifically a temporary amendment to the existing Parks Use Permit and a new, short-term water use approval from the Ministry of Forests.

Based on current consumption rates, water supply projections indicate lake levels could reach critically low levels by October 13, 2022. Installation of a siphon system at Edwards Lake will give access to an additional 526,000 cubic metres (m³) of water which would equate to approximately 16 days of water supply, anticipating that autumn rains will begin to replenish the watershed.

During the 2021 EOC, a siphon system was designed for Edwards Lake and materials were purchased. Ultimately installation did not proceed in 2021 as there was heavy rainfall which replenished the lakes in mid-September of that year. While materials are available to begin installation, the majority of the 2022 costs are for transportation and installation which will consist of six parallel runs of pipe which are 200 metres in length. Staff are also completing necessary work to fulfil the permit requirements, including archaeological and environmental impact assessments. These costs are included in the total funding request.

Emergency water supply from the Town of Gibsons

In addition, last year the Town of Gibsons (TOG) and SCRD entered into an agreement to supply emergency water to the Chapman Water System. TOG has notified the SCRD that they are prepared to assist again this year and are awaiting a formal request, so they can seek approval from the Province.

Organization and Intergovernmental Implications

Should the Board approve the proposed Edwards Lake siphon installation, the SCRD must seek support from the shishálh Nation for this project, an important step to receive provincial approval, particularly as Edwards Lake is in Tetrahedron Provincial Park.

Financial Implications

The installation of the 2022 Edwards Lake siphon is estimated to cost up to \$250,000. As part of the conditional use permit from BC Parks, the Edwards Lake siphon system would also need to be decommissioned and removed from site in 2023, which is estimated to cost \$100,000. The total cost for the 2022 Edwards Lake siphon system is \$350,000.

The proposed funding for this project is from the Regional Water Service [370] operating reserves as the siphon is of a temporary nature. Currently the estimated uncommitted operating reserve balance is \$1.2 million.

Timeline for next steps

Unless there is significant rainfall before the end of September, installation of the siphon system at Edwards Lake will take place during the week of October 3 to October 7, 2022. The siphons will be operational as soon as they are assembled. Based on the Chapman Lake siphon system,

staff anticipate the siphons at Edwards Lake could be installed and operational by Friday, October 7, 2022.

Communications Strategy

Should the SCRD receive approval, on September 28, 2022, staff will notify BC Parks, shíshálh Nation and Ministry of Forests if installation of the siphon system at Edwards Lake will proceed. Staff will continue with messaging to the public about the importance of water conservation during Stage 4.

STRATEGIC PLAN AND RELATED POLICIES

This project is aligned with the core strategy to ensure year-round water availability.

CONCLUSION

The Sunshine Coast has not received any significant rainfall since Stage 4 water conservation regulations were enacted and there is no rainfall in the short-term forecast.

It is recommended that installation and decommissioning of a siphon system at Edwards Lake be approved in the amount of up to \$350,000 and funded through Regional Water Operating Reserves. Staff also recommend that the SCRD Board seek approval shishalh Nation to proceed with the installation of the Edwards Lake Siphon System and request Emergency Water Provision from the Town of Gibsons through a formal agreement.
