# Appendix A: Name Proposals

- Change the name of Hunaechin Creek to "xenichen stulu" for the creek that flows SW into Skwawka River.
  - "xenichen stulu" is the shashishalhem name for Hunaechin Creek (advice from shishalh Nation Stewardship and Territorial Land Management Division, 2022).
  - "xenichen stulu" refers to the creek that flows into the bay at the "xenichen" village site. The name roughly means "go to the end until you can't go any further" referring to the northern extent of the swiya (advice from shíshálh Nation Stewardship and Territorial Land Management Division, 2022).
  - "xenichen," a major village site at the mouth of "xenichen stulu," is at the head of lekw'emin (Jervis Inlet) and is one of the locations where the spelemulh (first peoples/ancestors) first came from the sky by the Creator (advice from shishalh Nation Stewardship and Territorial Land Management Division, 2022).
  - The current English name, Hunaechin Creek, uses an anglicised version of the shashishalhem name (advice from shíshálh Nation Stewardship and Territorial Land Management Division, 2022).
  - The mouth of this creek is located at: 50.21528, -123.99083.
  - Name record: <u>http://apps.gov.bc.ca/pub/bcgnws/names/75519.html</u>.
- 2. Change the name of **Mount Victoria** to "k'els" for the mountain at the head of Queens Reach, Jervis Inlet (lekw'emin), NE of Powell River (city).
  - "k'els" is the shashishalhem name for what is currently called Mount Victoria, it means anchor and is associated with a legend site (advice from the shishalh Nation Stewardship and Territorial Land Management Division, 2022).
  - Gilbert Joe's, shishálh elder, site description: "one is that up at Jervis Inlet there's a
    mountain called Anchor Mountain. And it's called 'Anchor Mountain' because our
    forefathers called it 'k'els' in our dialect which means anchor. And on top of that
    mountain it's over 6,000 feet the snow line is about between 4,000 and 5,000 feet and
    where the snowline ends there's no shrubbery and evergreens that grows above that line,
    nothing at all because there's snow on top of those peaks just about ten (10) months out
    of the year or maybe even more. But on top of Anchor Mountain there's this Douglas fir
    tree roots and branches and all laying up there above the snow line. How did it get up
    there? Legends from our forefathers says that it got up there from the great big flood a
    long time ago" (advice from the shishálh Nation Stewardship and Territorial Land
    Management Division, 2022).
  - This mountain is located at: 50.24805, -123.98333.

- 3. Adopt the name "**xenichen**" for the site located at the junction of Hunaechin Creek (<u>xenichen</u> stulu) and Skwawka River.
  - "xenichen" was a major village site at head of lekw'emin (Jervis Inlet) and one of the locations where the spelemulh (first peoples/ancestors) first came from the sky by the Creator. The name roughly means "go to the end until you can't go any further" referring to the northern extent of the swiya (advice from shíshálh Nation Stewardship and Territorial Land Management Division, 2022).

- 4. Change the name of **Deserted River** to "ts'unay stulu" for the river that flows SW into Deserted Bay (ts'unay), NE end of Princess Royal Reach, Jervis Inlet (lekw'emin).
  - "ts'unay stulu" is the shashishalhem name for what is currently called Deserted River (advice from shíshálh Nation Stewardship and Territorial Land Management Division, 2022).
  - Current name of "Deserted" is based on settler perception and faulty concept of terra nullius (empty land) (advice from shishalh Nation Stewardship and Territorial Land Management Division, 2022).
  - The mouth of this river is located at: 50.09250, -123.74194.
  - Name record: <u>http://apps.gov.bc.ca/pub/bcgnws/names/75520.html.</u>
- 5. Change the name of **Deserted Bay** to "**ts'unay**" for the bay at the NE end of Princess Royal Reach, Jervis Inlet (lekw'emin).
  - **"ts'unay"** is the shashishalhem name for what is currently called Deserted Bay and shares the name "ts'unay" with the major village site that was located on the bay (advice from shíshálh Nation Stewardship and Territorial Land Management Division, 2022).
  - Current name of "Deserted" is based on settler perception and faulty concept of terra nullius (empty land). Nearby shishalh Nations Lands is misspelled "Tsooahdie" – possibly an early anglicization of ts'unay (advice from shishalh Nation Stewardship and Territorial Land Management Division, 2022).
  - This bay is located at: 50.09139, -123.77028.

- 6. Adopt the name "ts'unay" for the site located at the mouth of Deserted River (ts'unay stulu), on the shore of Deserted Bay (ts'unay).
  - "ts'unay" was the major village site that was located at the mouth of the "ts'unay stulu" (Deserted River) (advice from shishalh Nation Stewardship and Territorial Land Management Division, 2022).

- 7. Change the name of the NE part of **Jervis Inlet** to "**lekw'emin**", made up of Prince of Whales Reach, Princess Royal Reach, and Queens Reach.
  - "lekw'emin" is the shashishalhem name for Jervis Inlet. The name "lekw'emin" means "inlet" and it can be used to denote any inlet in general terms, however, Jervis Inlet was known as "lekw'emin" because it was the largest inlet in shishalh swiya (advice from shishalh Nation Stewardship and Territorial Land Management Division, 2022).
  - This inlet is located at: 50.00957, -123.93649.
  - Name record: <u>http://apps.gov.bc.ca/pub/bcgnws/names/74767.html.</u>

- 8. Change the name of **Earls Cove** to "skelh" for the cove at the N end of Sechelt Peninsula, facing the N end of Agamemnon Channel.
  - "skelh" is the shashishalhem name for the location of present-day Earls Cove. This name is likely an ancient name and the meaning has been lost over time (advice from shíshálh Nation Stewardship and Territorial Land Management Division, 2022).
  - This inlet is located at: 49.75333, -124.00917.
  - Name record: http://apps.gov.bc.ca/pub/bcgnws/names/74769.html.
- 9. Change the name of **Pender Harbour** to "<u>kalpilin</u>" for the harbour along the NW side of Sechelt Peninsula, between Sechelt and Powell River (city).
  - "<u>kalpilin</u>" is the shashishalhem name for the location of present-day Pender Harbour. For the shishalh, the place name <u>kalpilin</u> has been associated with the use of the region to shelter from the wind and rough sea. Therefore, the shishalh associate the name <u>kalpilin</u> with its use as a 'sheltered area'. The direct translation of <u>kalpilin</u> means 'coming around/detouring in a certain direction'. In context, this direct translation refers to the shishalh use of the <u>kalpilin</u> (Pender Harbour) area. The direct translation further explains how the shishalh would detour or come to this area to live and seek shelter from the wind and rough seas (advice from shishalh Nation Stewardship and Territorial Land Management Division, 2022).
  - The shíshálh comprise of four subgroups with each subgroup associating with geographical areas in the shíshálh swiya (land). The s<u>xix</u>us subgroup, was centered around <u>k</u>alpilin (Pender Harbour), with its main village at se<u>x</u>w?amin (Garden Bay). During the winter season, all four shíshálh subgroups would come to live together throughout <u>k</u>alpilin, with its major winter village at se<u>x</u>w?amin (Garden Bay) (advice form shíshálh Nation Stewardship and Territorial Land Management Division, 2022).
  - This harbour is located at: 49.62833, -124.03750.

- 10. Adopt the name of "mala/Hind-Smith Lake" for the lake E of Chapman Lake, NW of Panther Peak, within Tetrahedron Park.
  - The name mala is the shishalh ancestral name for Albert Louie. The name mala is the shishalh name of Albert Louie's maternal grandfather. Albert was honoured to be given this name to carry on the tradition of connecting to his ancestors and to his land of origin. As is tradition, this name has continued to be passed down to Albert's descendants and will continue to link the families to their ancestry, history, and lands (advice from shishálh Nation Stewardship and Territorial Land Management Division, 2022).
  - Albert Louie was born November 27, 1935. mala was a respected shishalh Elder who lived his entire life in the shishalh swiya, with his primary residence in the village of ch'atlich (Sechelt). mala lived his early life exploring the shishalh swiya in his family dugout canoe, living in his family homesteads and living off the natural resources provided by land and ocean. mala was a great knowledge keeper of shishalh language and history and worked tirelessly throughout his life to preserve shishalh language and culture. mala was a great provider to his family and community due to his abilities and actions as a hunter, fisherman, logger and family man. mala was a man who fished all shishalh waters and hunted and gathered resources from the ocean all the way to the mountain tops and

boundaries of shíshálh swiya. mala passed away in 2012 (advice from shíshálh Nation Stewardship and Territorial Land Management Division, 2022).

- John Hind-Smith came to live on the Sunshine Coast in 1960. He is described as a "spiritual elder for the conservation community of the Sunshine Coast" and was an integral part of the Tetrahedron Alliance, which contributed to the creation of the Tetrahedron Provincial Park. He is described as a life-long lover and protector of nature and was a voice for calm and respect when facing opposition to conservation efforts. In 1994, the SCRD honorarily renamed "No Name Lake" in the sub-alpine region of Tetrahedron Park to John Hind-Smith Lake, however this designation was not officially gazetted at the time. John Hind-Smith passed away in 2005, and in 2019 his friends and colleagues in the conservation community proposed to the shishalh Nation that No Name Lake be officially re-named to recognize both John Hind-Smith and a shishalh name (see "mala" above) (advice from shishálh Nation Stewardship and Territorial Land Management Division, 2022).

#### **RECOMMENDATION(S)**

THAT the report titled SCRD Sanitary Landfill Site Bylaw No. 405 and Waste Collection Bylaw No. 431 Amendments be received for information;

AND THAT Biodegradable Products Institute (BPI) certified compostable bags be permitted within the SCRD food waste curbside collection program and at the Pender Harbour Transfer Station Food Waste drop off site;

AND THAT the date for enforcement of new SCRD disposal regulation for food waste, food soiled paper and paper be amended from October 1 to November 1, 2022;

AND FURTHER THAT the Board proceed with readings and adoption of amendment bylaw 405.25 and 431.27.

#### BACKGROUND

Sunshine Coast Regional District (SCRD) Sanitary Landfill Site Bylaw No. 405, 1994 (Bylaw 405) regulates and sets out requirements for the disposal of solid waste at the SCRD disposal facilities. SCRD Waste Collection Bylaw No. 431, 1996 (Bylaw 431) regulates and sets out requirements for the curbside collection of solid waste.

At the January 28, 2021 meeting of the SCRD Board, the following resolution related to food waste and food soiled paper was passed:

026/21	Recommendation No. 1	Landfill Disposal Bans for Food Waste and
(in part)	Recycling – Considerations	

AND THAT a landfill disposal ban for food waste and food soiled paper from all sectors with a 5% volume based threshold be implemented;

AND FURTHER THAT the fees associated with the enforcement of these bans be implemented July 1, 2022.

At the April 28, 2022 SCRD meeting of the SCRD Board, the following resolution was passed:

103/22Recommendation No. 4Landfill Disposal Ban for Food Waste and(in part)Recycling - Proposed Amendment of Timeline for Enforcement

AND THAT the timing of implementation of fees associated with the enforcement of the landfill disposal ban for food waste, food soiled paper and paper be amended from July 1, 2022 to October 1, 2022.

SCRD staff have been working towards successful implementation of this regulation by providing broad outreach to all sectors, developing new operations procedures, and pursuing a local food waste solution for Electoral Area A.

The purpose of this report is to seek approval to adjust the timing of the food waste regulation enforcement to November 1, 2022, to seek approval to allow for BPI certified compostable bags within the food waste program, and to seek support to amend Bylaw 405 and Bylaw 431 accordingly.

#### DISCUSSION

While preparing the pending bylaw amendments related to the new food waste regulations, staff have identified two topics to be considered by the Board for inclusion in these Bylaw amendments.

#### Disposal Regulation Enforcement Timing

Successful implementation of the new disposal regulations is contingent on all residents having local access to food waste drop off or collection. This will allow for practical and easy compliance. Salish Environmental has been secured to provide a food waste drop-off bin at Pender Harbour Transfer Station (PHTS) and process the food waste at their Sechelt location. The bins are a custom order requiring at least six weeks for delivery, making November 1 the confirmed starting date for the Area A food waste drop off program. Shifting the enforcement date throughout the SCRD to November 1 will align with the Area A food waste drop off start date. It will also allow for more cohesive messaging for residents throughout the SCRD, as well as consistency of training for staff who will be implementing the new regulations. Staff therefore recommend that the associated amendments to Bylaw 405 and Bylaw 431 come into effect on November 1, 2022 instead of October 1, 2022.

#### Food Waste Bags

When the SCRD's curbside food waste program began, residents were only permitted to use paper bags or paper to wrap their food waste. Salish Soils recently advised the SCRD that Biodegradable Products Institute (BPI) certified compostable bags are acceptable within their food waste processing system. The Town of Gibsons is currently accepting BPI certified compostable bags within their foods waste program and it is anticipated that other local governments may follow suit. As a move towards consistency across the Sunshine Coast, as well as increased options for residents, staff recommend to amend Bylaw 431 and Bylaw 405 to allow for these bags to be accepted as of November 1, 2022.

#### **Options and Analysis**

*Disposal Ban Enforcement Date:* Adjusting the date to November 1, 2022 for enforcement of the disposal regulations will allow for a more consistent approach throughout the Sunshine Coast, as well as ease of messaging. Maintaining the date of October 1, 2022 for enforcement will make compliance for Area A residents difficult for the first month, as well as make the outreach messaging less clear. The bylaw amendments required to support the new regulations are bound by a date, with it being difficult to implement for October 1 if the Area A food waste program is not yet operational.

*Food Waste Bags:* Allowing BPI certified compostable bags will allow one more option for residents. The only risk of allowing these bags is the potential that people will inadvertently use bags that are not allowed, thinking they are compostable, thereby creating issues for the processor. The communication plan staff have developed attempts to support clear, concise and thorough messaging so residents know what bags will and will not be accepted.

#### Communications Strategy

Communication plans have been drafted to inform the public about these bylaw amendments. They will be implemented pending Board approval of the proposed bylaw amendments and will include a news release, website updates, social media and radio posts, as well as information available at Pender Harbour Transfer Station and Sechelt Landfill.

#### STRATEGIC PLAN AND RELATED POLICIES

The SCRD's 2019-2023 Strategic Plan includes implementing a Regional Organics Diversion Strategy. Implementing disposal regulations that support organics diversion, and implementing systems that allow for easy compliance, help to meet this target.

The Regional Organics Diversion strategy is in support of the SCRD's Solid Waste Management Plan's (SWMP) targets of 65-69% diversion, with organics diversion being one of the SWMP's reduction initiatives.

#### CONCLUSION

New disposal regulations have been adopted for the Sunshine Coast. The Food Waste Drop Off Program for Pender Harbour Transfer Station has now been secured and will commence on November 1, 2022. Staff recommend adjusting the enforcement timing to align with the commencement of the Pender Harbour Food Waste Drop-off. The bylaw amendments would be dated to align with this as well. Also, staff recommend that for consistency and increased choice for residents, BPI certified compostable bags be permitted for food waste.

Staff recommend amendments to Bylaw 405.25 and Bylaw 431.27 be given three readings and be adopted.

#### BYLAW NO. 405.25

#### A bylaw to amend Sunshine Coast Regional District Sanitary Landfill Site Bylaw No. 405, 1994

The Board of the Sunshine Coast Regional District in open meeting assembled enacts as follows:

- 1. This bylaw may be cited as *Sunshine Coast Regional District Sanitary Landfill Site Amendment Bylaw No. 405.25, 2022.*
- 2. Sunshine Coast Regional District Sanitary Landfill Site Bylaw No. 405, 1994 is hereby amended as follows:
  - a) Insert new definitions in Section 1 **INTERPRETATION**, as follows:

**"BPI certified compostable bag"** means bags that bear the Biodegradable Products Institute (BPI) compostable bag certification;

**"Food Soiled Paper"** means and includes paper towels, paper napkins, food soiled cardboard, food soiled newspaper;

**"Food Waste"** means municipal food waste, food soiled paper and cut flowers and house plants generated by any premises but does not include yard and garden green waste or plastics of any kind including biodegradable or compostable plastics;

"**Non-Separated Waste**" means waste that arrives at the landfill sites that is not separated into clearly distinguishable accumulations of recyclable materials, controlled waste or municipal solid waste;

"Paper" means printed paper and boxboard;

b) Strike out the definition for "**Recyclable Materials**" in Section 1 <u>INTERPRETATION</u>, and replace it with the revised definition, as follows:

**"Recyclable Materials"** means all source separated items, such as scrap metal, tires, hot water tanks, MARR appliances, yard and garden waste, gypsum wallboard, mattresses, cardboard, food waste, food soiled paper, paper and other materials accepted at the drop off area excluding municipal solid waste;

c) Strike out the definition for "**Source Separated Waste**" in Section 1 INTERPRETATION, and replace it with the revised definition, as follows:

"Source Separated Waste" means municipal solid waste, recyclable materials and controlled waste that arrives at the landfill sites and which is separated by means of barriers or placement into clearly distinguishable accumulations.

d) Strike out the definition for "**White Goods**" in Section 1<u>INTERPRETATION</u>, and replace it with a new definition for MARR (Major Appliance Recycling Roundtable) Appliances, as follows:

**"MARR (Major Appliance Recycling Roundtable) Appliances"** means metal household appliances such as refrigerators, freezers, clothes washers, clothes dryers, dishwashers, ranges, range hoods, built-in ovens, built-in microwaves or over-therange microwave ovens, air conditioners, trash compactors, food waste disposers, built-in hot beverage dispensers, water coolers and dehumidifiers.

- e) In Section 3 **OPERATIONS**, strike out subsection h) in its entirety and replace with the revised subsection h) as follows:
  - h) Use of the landfill site may be denied to persons who do not obey the directions given by the Attendant, Operator, or other designated Regional District Staff or who are in violation of the current regulations of the Waste Management Branch.
- f) In Section 3 **OPERATIONS**, strike out subsection j) in its entirety and replace with the revised subsection j) as follows:
  - j) Children under the age of 14 years, and all pets, are not permitted on the landfill site except when they are inside a vehicle.
- g) In Section 4 <u>MATERIALS PERMITTED AND PROHIBITED ON-SITE</u>, strike out subsection e) in its entirety and replace with the revised subsection e) as follows:
  - e) Disposal of undisclosed controlled waste or undisclosed asbestos-containing material is not permitted.
- h) In Section 4 MATERIALS PERMITTED AND PROHIBITED ON-SITE, add new subsections i) and j) as follows:
  - i) Disposal of loads containing food waste that exceeds 5% of the total volume of the load is considered non-separated waste and must pay a fee in the amount set out in Schedule B as attached and forming part of this bylaw.
  - j) Separated food waste being disposed of at Pender Harbour Transfer Station Site must be deposited into the food waste bins in the following manner:
     i) uncontained,
    - ii) contained within compostable paper bags, or
    - iii) contained within BPI certified compostable bags.
- i) Delete Schedule "B" in its entirety and replace with the revised Schedule "B" attached hereto.
- 3. This bylaw comes into force and effect on November 1, 2022.

- 7) The weight of materials delivered to the landfill site, on which fees are based, will be determined by:
  - a) Measuring the weight on the scale provided at the landfill site; or
  - **b)** In the event that the scale provided is not operational, weight will be estimated by the landfill Attendant employed by the Sunshine Coast Regional District.
- 8) All charges referred to in Sections 1 through 8 will be rounded up or down to the nearest quarter of a dollar.

#### BYLAW NO. 431.27

#### A bylaw to amend Sunshine Coast Regional District Waste Collection Bylaw No. 431, 1996

WHEREAS pursuant to *Sunshine Coast Regional District Refuse Collection Local Service Bylaw No. 1021, 1994*, the Sunshine Coast Regional District is authorized to provide a service for the collection of waste;

AND WHEREAS the Sunshine Coast Regional District adopted a rates and regulations bylaw in relation to the collection of municipal solid waste cited as *Sunshine Coast Regional District Waste Collection Bylaw No. 431, 1996*;

AND WHEREAS the Board of the Sunshine Coast Regional District wishes to amend Bylaw No. 431;

NOW THEREFORE the Board of the Sunshine Coast Regional District, in open meeting assembled, enacts as follows:

- 1. This Bylaw may be cited as Sunshine Coast Regional District Waste Collection Amendment Bylaw No. 431.27, 2022.
- 2. Sunshine Coast Regional District Waste Collection Bylaw No. 431, 1996 is hereby amended as follows:
  - a) Add new definitions in Section 1.0 as follows:

**"BPI certified compostable bag"** means bags bearing the Biodegradable Products Institute (BPI) compostable bag certification.

"Paper" means printed paper and boxboard.

b) Delete the definition in Section 1.0 for "Collectible Garbage" in its entirety and replace with the revised definition for "Collectible Garbage" as follows:

"Collectible Garbage" means municipal solid waste of a non-toxic nature generated by residential premises from normal household use and capable of being contained in a garbage can but does not include: paper, metal, cardboard, wood, roofing, gypsum, asbestos containing materials, collectible food waste, yard and garden green waste; commercial waste; industrial waste; institutional waste; demolition, construction and land clearing waste; hazardous (including pathogenic and radioactive) waste; explosive substances; chemicals which may create hazardous working conditions; material hot enough to start combustion; waste oil or petroleum by-products; waste paint; lumber, stumps or timbers; fish feed bags; batteries; or, undigested septic sludge.

- c) Delete section 4.3 in its entirety and replace with a new Section 4.3 as follows:
  - 4.3 Collectible food waste may be placed uncontained in the food waste can or contained in paper, a paper bag or a BPI certified compostable bag.
- d) This bylaw comes into force and effect on November 1, 2022.
