

Home Composter Rebate: Pre-approval Application

Submit this application before purchasing your new home composter. SCRD pre-approval of application reserves a rebate for up to 90 days. Pre-approval applications will be accepted until funds are fully allocated.

The SCRD is offering a rebate for up \$100 per household towards the purchase a home composter or materials to build an approved Home Composter.

Applicants must:

- Be the home owner and a resident of SCRD Electoral Areas A, B, D, E, or F, including residents of islands located in the aforementioned Electoral Areas, or residents of local municipalities of District of Sechelt, Sechelt Indian Government District or Town of Gibsons¹.
- Install the Home Composter on the address in the application form.
- Acknowledge only the home composter is eligible for a rebate. Additional materials and installation fees or landscaping materials, are not eligible for the rebate.
- Submit a completed application form and all supporting documents.

If you qualify for a rebate, an approval letter will be emailed to your email address below, or sent to your mailing address below. A complete list of eligibility and program requirements is available online at www.scrd.ca/composting
