APCs advise the Regional District Board on all matters referred to the APC by the Board or by the Area Director respecting land use, the preparation and adoption of a community plan, or a rural land use bylaw or a proposed bylaw or permit. Each Electoral Area has an APC. Some matters are considered regionally.

- 2. The SCRD Board will review applications and appoint 6-12 members to each APC.
