

Rainwater Harvesting Rebate: Pre-approval Application

Submit this application before purchasing your new rainwater storage. SCRD pre-approval of application reserves a rebate for up to 90 days. Pre-approval applications will be accepted until funds are fully allocated.

The SCRD is offering two levels of rebate to support the installation of new rainwater storage. A maximum of \$1000 in rebates is available per property. Rebates offered in 2024

- are: Up to \$500 towards a minimum storage volume of 4,500 litres
 - Up to \$1000 towards a minimum storage volume of 9,000 litres

Applicants must:

- Be residential customers with an SCRD water utilities account¹.
- Install the Rainwater Harvesting System on the address in the application form.
- Acknowledge only storage vessels (cisterns or tanks) are eligible for a rebate. Additional materials and installation fees, such as pumps and piping, are not eligible for the rebate.
- Submit a completed application form and all supporting documents.

If you qualify for a rebate, an approval letter will be emailed to your email address below, or sent to your mailing address below. A complete list of eligibility and program requirements is available online at <u>www.scrd.ca/rainwater</u>.

- ☐ The roof catchment area is at least 20 square meters (215.3 square feet). Additional roof catchment area is recommended to refill storage volumes larger than 4,500 litres.
- ☐ The storage vessel I intend to install has a storage volume of at least 4,500 liters.
- ☐ I understand that I am not pre-approved until I receive a confirmation letter or e-mail from the SCRD. Pre-approval expires 90 days after the letter is issued and unclaimed rebates will be redistributed, by the SCRD, to properties on the wait list.
- □ I understand that I will be required to provide an invoice and proof of payment for my storage vessels when I submit my claim form.
