



# Rainwater Harvesting Rebate: Claim Form

Submit this rebate Claim Form within 90 days of receiving your pre-approval letter from the SCRD.

Applicants who are pre-approved for the Rainwater Harvesting Rebate must complete rainwater harvesting installation and submit a completed Claim Form within 90 days in order to receive the rebate. Rebates are only provided against the purchase costs of the rainwater storage vessel (i.e., 'cistern' or 'tank') Additional materials or installation fees, such as pumps and piping, are not eligible for the rebate.

### 3. Rebate Claim\* (check one):

Up to **\$500** for installing a minimum of 4,500 litres of new rainwater storage

Up to **\$1000** for installing a minimum of 9,000 litres of new rainwater storage

*\* The Rainwater Harvesting Rebate Program will provide a rebate for the purchase of rainwater storage vessels, up to the amount outlined above. In the event that a storage vessel costs less than the allowable limit for the two tiers available, only the true cost will be rebated.*

### 4. Cistern (Tank) Safety

Like swimming pools, water cisterns can be dangerous for the children in your neighborhood as they are a drowning hazard. They also qualify as a confined space, and the air inside may not contain sufficient oxygen to allow a human to maintain consciousness. Please ensure you have taken all necessary precautions to ensure that your water cistern is installed and operated safely.
