

# SUNSHINE COAST REGIONAL DISTRICT CURRENT DEVELOPMENT APPLICATIONS

This report is generated monthly by the Planning and Development Department to present a snapshot and status of the following development application types:

Agricultural Land Reserve Application

Applications related to non-farm uses within the Agricultural Land Reserve.

Board of Variance Application

Applications to the Board of Variance to vary regulations such as building setbacks, height, or parking requirements, due to constraints that result in hardship.

Bylaw Amendment Application

Applications to amend land use regulations in Zoning Bylaw 722 or 337.

**Development Permit Application** 

Applications for a development permit to alter land, subdivide land, or construct buildings and structures in a Development Permit Area (DPA).

Development Variance Permit Application

Applications for a Development Variance Permit (DVP) is a permit to vary regulations such as building setbacks, height, or parking requirements. A DVP cannot be used to change the permitted uses or density of a property.

Frontage Waiver Application

Applications to reduce the minimum 10% required parcel frontage along a public road.

Official Community Plan (OCP) Amendment Application

Applications to amend goals, objectives, policies, and land designations in an OCP.

Property Information Request

Complex property information requests that require additional staff time to respond.

Remedial Approval

A comprehensive pre-application process required in cases where work has proceeded without the required development permit.

Strata Conversion Application

Applications to convert previosuly occupied buildings to a strata unit.

Subdivision Application

Applications to provide response to a Ministry of Transportation and Transit (MOTT) subdivision referral.

Tree Cutting Permit Application

Applications to authorize tree removal in areas designated in Tree Cutting Permit Bylaw 350.
